| <p><b>Measures based on the <a href="#">ZZUSUDJZ</a> and <a href="#">ZZUSUDJZ-A</a> acts</b></p> <p><i>Determination of deadlines for exercising material rights and for fulfilling material obligations, filing applications and serving documents.</i></p> <p>Note: expiration date - 31. 5. 2020</p> | <p><b>Measures based on the <a href="#">ZIUZEOP</a> act</b></p> <p><i>One-year extension of validity and funding for research and infrastructure programmes whose funding expires at the end of 2020, one-year extension of the deadline for the purchase of research equipment (Packages 17 and 18), one-year extension of bilateral projects with the USA and Russia</i></p> <p><b>Measures based on Act <a href="#">ZZUOOP</a></b></p> <p><i>The Minister responsible for science may, for the purposes of research in the field of COVID-19 in 2020, authorize ARRS to additionally finance research programs that were already selected in a public call in 2020 and proposed for funding by ZSA.</i></p> <p><b>Measures based on Act <a href="#">ZIUOPDVE</a></b></p> <p><i>Junior researchers whose deadline for the fulfilment of contractual obligations for the completion of training (defence of a doctoral thesis) expires in the period from 12 March 2020 to 31 December 2021 shall be awarded a one-year extension of the deadline.</i></p> |
